Please Contact BROOK at (810) 588-1909 if partial payment arrangements need to be made or if payment assistance is needed. Efforts are always made to not turn participants away. In order for financial assistance to be considered, please provide evidence of need with your registration to our office. An IRS tax income statement is recommended. You will be sent a scholarship form to fill out.

Due to our agreement with LETS transportation, any participants adding an activity less than one week prior to the activity date will need to make arrangements for their own transportation both to and from the event. Also after discussing things over with LETS they have proposed a new plan. They will continue to receive a list of riders from Brook, they will enter the riders into their system and it will allow their system to place you/them on different busses so that more of us can be on a bus and for a less amount of time. This new system trial will begin October 1st 2021. If for any reason this does not work for us or becomes too stressful we will reevaluate this arrangement. With this change our transportation fees will be going up \$.50. The new price will be \$5.50 per event.

Our transportation list will still be due to LETS one week prior to the activity.

Please Note:

We will not be able to allow Participants to participate in events without a filled out Registration form. We must also have updated information forms, Photo Release forms and all policies and procedures forms signed and dated yearly.

If you choose to bring your registration form with you instead of mailing it in, PLEASE email or take a picture and text it to BROOK within one week of the first event you plan on attending. If you need transportation for the event, you MUST let Brook know NO later than one week before the event.
